# **STORAGE AND RETENTION PERIOD**

# **COOKIES INFOS**

What are cookies?

A "cookie" is a text file saved on your computer when you access a website to provide information each time you return to the same site. It is a kind of reminder of the internet page visited. With the cookie, the web server sends information to the user's browser (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) that is stored on the user's computer, and will be re-read and updated each time the user returns to the site. In this way, the website can automatically adapt to the user. During navigation, the user may also receive cookies from different sites ("third-party" cookies) on his terminal, set directly by the managers of these websites and used for the purposes and in the manner defined by them. Depending on their duration, a distinction is made between session cookies (i.e. those that are temporary and automatically deleted from the terminal at the end of the browsing session by closing the browser) and persistent cookies (i.e. those that remain stored on the terminal until they expire or are deleted by the user). Depending on the function and purpose of use, cookies can be divided into technical cookies and profiling cookies.



#### Technical cookies

Some cookies are used to perform computer authentication, and session tracking and store specific information about users accessing a web page. These so-called technical cookies are often useful to enable you to navigate around a website and use all of its functionalities. Technical cookies are those whose use does not require the user's consent. Analytics cookies also belong to this category. These are cookies that collect information about a user's use of a website and allow the website to function better. For example, analytics cookies show which pages are visited most frequently, allow us to see what the recurring patterns of use of a website are, and help us understand any difficulties the user encounters in using it.

### **Profiling cookies**

Other cookies may instead be used to monitor and profile users while they are browsing, studying their movements and web browsing or consumption habits (what they buy, what they read, etc.), including to send targeted and personalised service advertisements. We speak in this case of profiling cookies. The use of said cookies requires the prior acquisition of the user's free informed consent under Article 7 of EU Regulation 2016/679 and the national legislation in force.

# Third-party cookies

It may also happen that a web page contains cookies coming from other sites and contained in various elements hosted on the page itself, such as advertising banners, images, videos, maps or specific links to web pages of other domains residing on servers other than the one on which the requested page is located. In other words, these cookies are set directly by website operators or servers other than this website. We speak, in these cases, of so-called third-party cookies, which are usually used for profiling purposes. The use of these cookies requires the prior acquisition of the free, informed consent of the user.

# Types of cookies used by our site

The main functions of the cookies installed by http://www.alidaunia.it/ are technical, they are used to constantly improve the Service, for authentication, and for statistical purposes, such as counting site visits. The use of cookies is therefore strictly to facilitate the functions of the server when browsing the Service.

The site also allows the following third-party cookies to be sent. These cookies are not tools that we own, so for more information, you can access the information and consent forms of the third parties by clicking on the links provided.

To improve the website and understand which parts or elements most are appreciated by users, third-party cookies from Google Analytics are used as an anonymous and aggregate analysis tool. These cookies are not tools that we own; for more information, therefore, you can consult the information provided by Google.

The pages of the website incorporate certain Facebook and Google Plus widgets and share buttons, to allow you to share content from the website on your social channels, and to interact with our channels. These cookies are not owned by us but are created by Facebook and Google respectively when you use the respective widget or share button.
